Biodiversity Net Gain update

- Kent BNG Officer recruited Nicky Britton-Williams, seconded from KWT, starts 15th March.
- Development of BNG sites register for autumn 2023.
- Defra BNG grant potential capacity building.
- Government response to 2022 BNG regulations and implementation consultation published.

Government's BNG response headlines (1)

- Additional funding for LPAs of £16.71 million for preparation; more to come through new burdens funding.
- Mandatory BNG will definitely start November 2023.
- BNG requirements for small sites delayed to April 2024.
- NSIPs requirement for BNG no later than November 2025.
- More detail to come in secondary legislation and guidance still lots of unknowns.
- Exemptions clarified previously developed land and change of use will NOT be exempt.

Government's BNG response headlines (2)

- BNG statement required at planning application stage.
- Biodiversity gain plan to be approved prior to commencement national template to be provided.
- On-site and local off-site BNG incentivised through metric 'strategic significance' score.
- LPAs can sell biodiversity units, but can't direct developers to use them unless 'there are clear ecological justifications to do so'.
- Government won't be providing a trading platform or brokering service.

Government's BNG response headlines (3)

- Natural England will operate the biodiversity gain register. This will:
 - act as a public register for off-site BNG
 - <u>not</u> act as a marketplace
 - <u>not</u> assess ecological suitability or additionality this will be the responsibility of whoever the legal agreement is made with
- Government is 'exploring' how on-site net gains can be included in the register.
- Can stack habitat creation/enhancement, as long as it's additional guidance provided.

Government's BNG response headlines (4)

- Statutory biodiversity credits will be sold by Natural England on behalf of Secretary of State through a digital platform.
- Indicative credit price will be available six months before mandatory but no information on when platform will open.
- Credits remain a last resort.
- Local credit schemes will not be possible.

Government's BNG response headlines (5)

- The planning enforcement regime will be the principal way of enforcing delivery of BNG
- LPAs will need to ensure gains are appropriately secured to enable effective enforcement.
- Guidance and training to be provided on use of planning conditions, obligations and conservation covenants.
- No further information on biodiversity reporting requirements provided.
